6 ways to pay your property taxes

1. Pre-authorization plan

Looking for a simple property tax payment option that saves you time? Set up a monthly pre-authorization payment plan or automatic withdrawals on tax due dates. Plans are:

2. At your Bank

Pay at your Canadian bank or credit union in-person, by telephone banking, or through your bank's online banking website or mobile app. The payee is Norfolk County Taxes, the property roll number is the account number, and add a 0 on the end if 16 digits are required. To avoid late fees, please ensure you are aware of your bank's processing times. **Payment by e-Transfer is not available.**

3. In person at ServiceNorfolk

5. Online with a credit card

Payment due dates



The first installment of your interim bill is due **August 29, 2025.**



The second installment of your interim bill is due **October 31, 2025.**

Late payments

If your tax payment is late, you'll be charged a \$10.35 fee when we send you a reminder notice. To avoid this fee, please make sure to pay by the due date shown on your tax notice.

Tax arrears

Property owners with accounts in arrears may discuss payment options by contacting 519-426-5870 or 226-NORFOLK, extension 1666.

Supplemental tax bills

Changes, additions or improvements to your property could result in a change to your property assessment and a supplemental tax bill. Supplementary taxes are in addition to the amounts already billed for property taxes and can apply to a maximum of three tax years. Supplementary bills are issued between August and December.

Reductions, cancellations or refunds

You may be eligible for a reduction, cancellation or refund of your property taxes based on certain circumstances or changes related to your property such as demolition or a building destroyed by fire. Visit norfolkcounty.ca/Adjustment for full criteria.

Understanding government roles: Who to contact for specific issues

Issues are best managed when everyone understands the roles and responsibilities of different levels of government. For example, a Member of Parliament (MP) cannot make decisions about property taxes, just as a Mayor cannot make decisions about employment insurance. Find contacts at norfolkcounty.ca/Government.



Canada

Federal government is responsible for national and international affairs, including things like defence and employment insurance. Contact your Member of Parliament (MP).



Ontario

Provincial government is responsible for regional issues and providing services like healthcare and education. Contact your Member of Provincial Parliament (MPP).



Norfolk County

Municipal government, made up of Council, led by the Mayor, is responsible for infrastructure, such as roads and water, and local services like garbage collection and building permits. The Councillor for your Ward is a member of Council and plays a role in shaping the community. **Contact your Councillor** to share feedback on municipal issues or community priorities.

Municipal staff help deliver services and programs. **Contact ServiceNorfolk** for questions or help with your tax bill, or other day-to-day municipal services. Contact details are below.
