## **Infection Control Updates**

Masks are recommended but no longer required throughout the home. In outbreak situations, or if a resident is on Additional Precautions, all visitors and staff are to comply with masking and other PPE requirements as directed by the Outbreak Management Team and the local Public Health Unit.

Passive screening continues for all staff and visitors. Please continue to self-monitor for any COVID-19 compatible symptoms or other respiratory or infectious diseases to prevent the spread of illness. Visitors should continue to avoid visiting for 10 days after symptom onset or positive COVID-19 test result (whichever came first).

Residents with COVID-19 remain under isolation and under additional precautions for 10 days. Residents can leave their room after 5 days while wearing a mask. If unable to wear a mask, residents will be required to complete a 10 day isolation period in their room.

COVID-19 booster vaccinations are recommended for residents every 6 months as per the Ministry of Health. We will be hosting a Fall Booster Clinic for eligible residents

#### **Pet Visits**

We would love to see your furry friends visit the home but we do have a process to follow prior to them coming in.

The requirements for someone to bring in a dog for a pet visit is they need to provide a copy of their most recent vaccinations, which need to be valid for the current year.

This document will be required on an annual basis if the dog is to continue coming into the home.

There is a pet visit binder that is now kept at the Reception desk. The binder holds a copy of the dog's vaccination paperwork; the pet visitor policy that needs to be read by the handler and signed off as well as, the handler's contact information. The dog and their handler cannot proceed with a visit unless these steps are completed.
