Dignity Walk

Residents in the final stages of life deserve comfort and care with dignity and respect. A person who is treated with dignity during life should also be treated with dignity after death. To reinforce this belief, we provide a dignity walk for our deceased Residents.

With the permission of the family, the staff of Norview Lodge, in partnership with the funeral home of choice, will cover the Resident with a dignity quilt for their final passage from the home. Family members may choose one of our dignity quilts.

The dignity walk is announced so that staff and Residents throughout the home may participate. Family members are invited to walk with staff and Residents as they accompany the deceased Resident from their Resident home area to the front entrance. Once again, with the permission of the family, a dignity poem is read prior to the final exit from the home.

Masking Update & Outbreaks

As of December 21, 2023, we have shifted to Universal Masking within the home for all staff, visitors, essential caregivers, students, volunteers, and support workers.

Visitors and essential caregivers are required to mask within the home at all times except when sharing a meal/eating/drinking with a resident in their private room or in the designated space (ie. Activity room, Boardroom, Gathering Place).

Therefore visitors/families/caregivers can no longer share a meal and/or drink in the communal spaces within the home.

There are times that Norview Lodge, in consultation with Public Health, must declare an Outbreak. Norview Lodge will initiate Infection Prevention and Control risk reduction measures for all Residents and staff and will work closely with Public Health during the Outbreak period.

Outbreak information will be relayed to the public by notices located on entrance doors and an update will be shared on our website.

Please note that during an Outbreak, essential caregivers are the only visitors who can visit Residents on droplet/contact precautions except when a Resident is end of life; in this case there are no restrictions to visitors. Any visitor who may be visiting a Resident on droplet/contact precautions must wear the appropriate PPE. There is no limit to the number of caregivers that can visit a resident.

If you would like to be considered as an essential caregiver, please reach out to the Social Worker or the Supervisor, Programs and Volunteer Services.
